 2. That John Stover of Carter Sloope will give a presentation at the September council meeting outlining the full scope of the project plans for the proposed sewerage system.
 3. That the presentation concerning the recreational splash pad will be held at the October council meeting. And it is a fresh-water splash pad that uses about the same amount of water as a single-family home.
